To achieve integrated care, those involved with planning and providing services must impose the user’s perspective as the organising principle of service delivery”*

RCP Future Hospitals Project

- * “Care, treatment and support services need to be delivered in a range of ways, across a range of settings and by a range of professionals, all working in collaboration. It is clear that all parts of the health and social care system, and the professionals that populate it, have a crucial role to play in developing and implementing changes that improve patient care and meet the needs of communities.”

Integrated Diabetes Services

- * A recognition that with changing demographics the model of service needs to change – “not just doing the same thing in a slightly different way”
- * Team within Oxfordshire, led from the CCG, aiming to develop an integrated diabetes service within Oxfordshire
- * 2 Consultants within OCDEM (Dr Rustam Rea and Dr Garry Tan) have previous experience of this from Derbyshire

Integrated Diabetes Care

- * A number of successful examples from around the country
 - * Derby
 - * Portsmouth
 - * West Berkshire
- * Local solutions
- * Useful Case Studies (RCP, Diabetes UK, Kings Fund)
- * How to generalise the learning?

The Project

- * Research Fellow to be appointed, funding from RCP with contribution to project from AHSN
- * To conduct qualitative, observational and quantitative research during the development and implementation of the integrated diabetes service in Oxfordshire
- * What are the key features of, and barriers to, developing an integrated service?

Evaluation

- * Effects of change in service on service users, processes and professionals
- * Impact on population level clinical outcomes
- * Implications of new service on training needs for healthcare professionals (including new specialist trainees)

Translation

- * Develop a toolkit which can be used to develop and implement sustainable integrated services in different locations, and across different long-term conditions
- * Include guidance for commissioners and policy-makers
- * Contribute to turning the ideals of the Future Hospital Report into meaningful clinical services

AHSN Funding

- * Aware that integrated diabetes services are being developed across the Thames Valley
- * Berkshire West in the vanguard, Buckinghamshire also making progress
- * Use learning, in conjunction with close evaluation of whole process in Oxfordshire, to help understand the key features which are required for all successful, sustainable integrated care models
